1.0 Purpose

Ste. Rose Health Centre (SRHC) which includes Ste. Rose General Hospital and Dr. Gendreau Personal Care Home is owned by the Catholic Health Corporation of Manitoba (CHCM), and is a faith based facility.

Therefore, in a manner that is consistent with our Catholic fundamental religious principles to which SRHC adheres, this policy will articulate that the facilities are to be considered an abstaining facilities and will not be providing medical assistance in dying (MAiD) within the hospital or personal care home.

Definitions

Assessment Process-The process for examination of the medical condition of a resident/client so that all appropriate and available therapeutic options for client/resident care can be identified, and the resulting consultation with a client/resident on those therapeutic options available to the client to address the client's health and medical needs, including the assessment of the client by an Authorized Practitioner in accordance with the MAiD clinical guide to determine whether the client meets the MAiD criteria.

MAiD or Medical Assistance in Dying: Circumstances where a medical practitioner or nurse practitioner, at an individual's request: (a) administers a substance that causes an individual's death; or (b) prescribes a substance for an individual to self-administer to cause their own death. The definition of MAiD, is not inclusive of processes that may (or may not) culminate in MAiD.

Conscientious Objection: The rejection of providing or participating in MAiD because such action would violate a personal, deeply held moral or ethical value.

Procedure

- 1. Access to Information**-As abstaining facilities, SRHC will ensure timely and accurate access to information regarding MAiD to a client/resident.

A client or resident who wishes to access medical assistance in dying will be directed to speak to their medical practitioner, and can be provided the contact phone number (204-926-1380) and email address (Maid@wrha.mb.ca) of the provincial service team.

As SRHC is committed to the provision of excellent health care, palliative care and care of the dying that aims to relieve suffering and improve both the quality of living, and dying as the most profound and living expression of compassion and respect for the dignity of every human person. SRHC will ensure to engage with the client/resident and their family to explore if any new goals of care are required or in need of change in an effort to ensure symptom management is maximized. We will also continue to provide excellent spiritual and emotional support to client/resident and the family, in accordance with our values and traditions.

The medical practitioner/SRHC staff will provide the Executive Director or designate with the information on the request to ensure the process is tracked to confirm that timely access and accurate information sharing occurred.

2. **Transfer of Care**-As abstaining facilities, SRHC will ensure that transfer of care from SRHC to another non-abstaining health authority facility or alternative location will occur in a safe, timely and coordinated manner for all clients/residents who have been assessed and decide to pursue MAiD. A resident/client may not be able to access MAiD if the individual is too ill or frail or refuses to be transferred to a non-abstaining facility or alternative location.

SRHC will follow Prairie Mountain Health (PMH) inter-facility transfer policy (PPG-00812) to facilitate the transfer.

SRHC will tolerate a third party assessment, as provided by the provincial MAiD team, to take place in whole or in part at SRHC, as approved by the Executive Director.

3. **Position Statement**-As abstaining facilities, SRHC will ensure to include the SRHC position statement (appendix A) as a handout to all residents' on admission to the personal care home. This position statement will be made available to any hospital client or as requested the public.
4. **Employee Education**-As abstaining facilities, SRHC will ensure employees are provided education on the provincial and regional MAiD policy/processes and the faith based position statement/policy of SRHC on hiring of all new staff. As well as current employees will be provided education through regular reviews/discussions of the provincial policy and SRHC position statement/policy.

- 5. Conscientious Objection-**As abstaining facilities, SRHC will ensure that those individuals who declare a conscientious objection to MAiD to the Executive Director will not be required to provide or aide in the provision of information sharing/transfer of care of the resident/client to the provincial MAiD team or with the process necessary for the third party assessment to occur on site.

SRHC staff who choose not to participate in any aspect of this policy will not be forced, coerced, or face retaliatory action as a result of choosing not to participate. SRHC will ensure clients/residents will still have access to requests for MAiD without delay.

SRHC will ensure staff who choose to aide the client/resident in information sharing/transfer of care for the assessment or when MAiD is to occur will also not face retaliatory action in participating in the establish processes that may or may not lead a client/resident to MAiD.
